Clerk's Report: Grace Salm reported on the following: 1) For the Partisan Primary Election we had a total of 293 votes. 2) After discussion a motion was made by Robert Christian and seconded by Henry Langenhahn to approve the Picnic License for the Smiling Moose – Moose Fest for August 25 & 26, 2018. Motion carried.

**Building Permits:** 3 were issued. **Grota Appraisals:** No report.

**Constable's Report:** Ian Quinn reported on the following: 1) A \$205.10 citation was issued to the Clements on Willmas Road for reoccurring loose horses. He is also planning on inspecting fences on their property. 2) The DNR Warden has been notified regarding a recent shingle fire on the Cliff Kissinger property on Moraine Road. 3) A concern was issued by Becky Salm for a cow in distress on W. Washington Road. 4) A warning was given to a town resident for loose chickens on a neighbor's property.

**Plan Commission**: Dennis Graf reported the Manitowoc County Board of Adjustments approved Dean Koenig stairway variance request on July 30, 2018.

**Roads & Equipment:** After discussion a motion was made by Robert Christian and seconded by Henry Langenhahn to approve a \$200.00 sanding charge to Mr. Nenning for a recent oil spill on Moraine Road caused by his tractor. Motion carried.

**Bridges**: Dennis Graf stated a letter was sent to the Town of Herman for ½ reimbursement for additional cost for the County Line Road Bridge project. The total additional cost for the Town of Herman was \$7,947.45 and ½ reimbursement to the Town of Meeme is \$3,973.25 from the Town of Herman. The Town of Herman can submit their reimbursement cost to Sheboygan County for the County Bridge Aid Program.

**Recycling & Transfer Station:** Peter Moehring stated he picked up 17 tires from the ditch by Randy Bonde's property on W. Washington Road.

**Town Hall – Bids for Gutters:** After reviewing the two bids for gutters from Altitude and Mathis Gutters a motion was made by Henry Langenhahn and seconded by Robert Christian to accept the lower bid from Mathis Gutters for \$350.00. Motion carried.

**Valders Ambulance Service**: Dennis Graf stated Valders Ambulance Service is looking to raise their prices from \$11.00 to \$21.00 per person. The Town of Meeme still has a contract with Valders Ambulance Service until the end of 2020.

Disaster Training with Manitowoc Co. EMA: Dennis Graf stated the Town Board met with Mr. Waack and his assistance, Amanda Fox and had a successful table top disaster drill exercise. Dennis Graf also thanked Richard Salm for developing the Town of Meeme's Disaster Emergency Plan. The EMA office will be also use our plan as a model for other town/villages in Manitowoc County. Grace Salm has already made changes and updates to our plan which have been submitted to Manitowoc Co. EMA office.
