**Treasurer's Report:** Treasurer Kathleen Dineen-Grube presented the Treasurer's Report. A motion to approve the Treasurer's report as presented was made by Henry Langenhahn and seconded by Susan Kracht. Motion Carried. Papers were signed for the bank account for the ARPA funds.

**Ordinances:** The ordinance which was approved at last month's meeting to allow ATVs/UTVs on Town Roads was signed and will be posted. Signs are ordered and will be installed as soon as they are received.

**Building Permits:** Henry reported he issued 5 building permits.

**Building:** The new furnace/ac has been installed and payment is in the current month's accounts payables.

**Roads,bridges & Equipment** \*A hole was found in the road on Rust Road which needs repairing.

\*It was found that that with the recent excessive rain, water did not run over the road on the west side of Mineral Springs Road. This was attributed to the recent cleaning out of the ditches on West Washington Road. Because of this, it was determined replacing the culvert West Washington Road was not necessary. The culverts that were purchased will be used for the problem on Rusk Road.

\*Blacktopping and repairs are completed.

\*Chip sealing will be performed on Meeme Creek Road

\*Tractor weights are in for the John Deere and will be installed sometime this week.

\*New culvert on Pioneer Road was running full after the latest heavy rains.

**Recycling & Transfer Station:** Discussion was to have an editable board in the recycling center listing recycling fees that could be changed as fees change. Sue will talk to Jim Punke. Val will also post fees on the website.

**Valders Ambulance Service:** June's electronic report is available upon request.

**Approval of Liquor License Renewals:** Motion to approve the renewals of 2 additional operators licenses was made by Dennis Graf and seconded by Susan Kracht. Motion Carried.
